Motion was made by Cody Ditto and seconded by Jay Holt to approve the previous minutes with following change. Anthing mobile to read Anywhere Mobile Medical. Motion carried 4-0.

Mario Flores would like permission to set up a food truck to sell Mexican/American food. It will be made fresh daily and prepared onsite. Jay Holt asked him to get the truck inspected by the county. Mario said all grease and gray matter will be disposed of in Colorado City. Council asked Mario to please let the City know where he will be setting up and also to get a food license with the county and to apply for a permit with us.

Jacky Richardson is interested in purchasing 413 S. Adams. He would like to remove the house there and place a home there.
