Motion to approve the previous minutes was made by Jay Holt and seconded by Sharon Dodson. Motion carried 3-0.

Vickie and Brian Fontana request permission to place a pre-fab house behind the Vickie Café building. It will be a single wide. Jay Holt said the City would have to approve a specific permit. Motion was made by Jay Holt and seconded by Cody Ditto to table the request. Motion carried 3-0.

Ashley Crawford is looking for a piece of property for her business. Her business Maple Porch is a meal prep and bakery. She was asking for help finding a place to put her business. 200 S. Adams and City property next to the Fire station is a great location. City agreed to sell a piece of land to her if an agreement can be agreed upon.
