David Alaman made a motion to approve previous minutes and motion was seconded by Sharon Dodson. Motion carried by all.

Discussed Water Line Replacement Final Acceptance by Sage Diller. The contract has been completed and installed and Sage Diller recommends that final payment of \$16,328.26 is remitted. David Alaman made a motion to approve payment and motion was seconded by Brandy Manning. Motion carried by all.

Discussion of new Ordinance Pertaining to Appearance, Maintenance, Use and Occupation of Property-contact Cameron Walker for all necessary documents for ordinance. David Alaman would like to see hiring of Code Enforcement Officer. Discussion tabled until further information is received.

Discussion of new electrical provider contract-Todd Malcom with ADK on video conference with energy proposal. City accepted rate of 0.345438 for 5 years (60 months). Todd Malcolm will send contract to lock in rate. City's current contract expires 12-31-2020 and new contract will be effective 1-1-2021. David Alaman made a motion to approve and motion was seconded by Cody Ditto. Motion carried by all.
