- 1. This meeting was called to order by the President, Kelly Seals at 7:02 p.m.
- 2. Kelly Seales led the prayer and Cody Ditto lead the pledge.
- 3. Kelly Seales read the public notice of requests for sealed proposals for the Coahoma City Park Splash Pad. Cody Ditto made a motion to opened the public hearing, Seconded by Richard Crawford and motion passed 4/0. Lori Martinez informed the board she is getting information on signage for the splash pad. She also presented that Coahoma Pride could dedicate \$50,000 at this time to the project and would continue to raise money towards the cost of the splash pad.

She will get a proposal on her fee and the cost of supplies needed to complete the two murals. Once received she will present to board for consideration.

- 12. Board considered the Letter Agreement with Coahoma Pride. Following review and discussion of the Letter Agreement a motion was made by Richard Crawford to approve the Letter Agreement and Seconded by Cody Ditto, motion passed 4/0.
